Newrange Gold Grants New Stock Options and Re-prices Previous Stock Options Granted to Employees and Consultants

("Newrange" or the "Company") announces that today the Company granted to directors, officers, employees and consultants an aggregate of 3,445,597 share purchase options with an exercise price of \$0.08 per share and a term of five years.

In addition, the Company has repriced a total of 2,219,403 outstanding employee and consultant stock options to \$0.08 per share (original grant dates: February 16, 2017, March 24, 2017, March 29, 2017, April 25, 2017, July 10, 2017 and August 28, 2017).
